## Bob Chreste, Georgetown, TX

Bob Chreste is an active arranger, consultant, and adjudicator residing in Georgetown, Texas. Bob spent 16 years as a high school band director at several prominent programs in Texas. Mr. Chreste is currently on the brass staff for the Bluecoats Drum & Bugle Corps and has previously worked with Carolina Crown, Santa Clara Vanguard, and The Cadets. Bob is one of only a few instructors in DCI that have been a brass caption head and a visual caption head at a finalist corps. Bob has been a clinician at the Music for All Summer Symposium, Midwest Clinic, Texas Bandmasters Association, and many other conferences.

In addition to Bands of America, he adjudicates for Winter Guard International, Texas Music Adjudicators Association, and several other local, regional, and state level circuits. Bob has an accomplished performance background as well. In 2001 and 2002, he was a conductor and a musician in the Tony and Emmy Award winning musical production, Blast! His educational background includes receiving his Bachelor of Music degree from the University of Houston in 2000 and his Master of Music degree from Sam Houston State University in 2003.

## Jarrett Lipman, San Antonio, TX

Jarrett Lipman is the Director of Bands at Claudia Taylor "Lady Bird" Johnson High School in San Antonio, Texas. Mr. Lipman is also the Brass Caption Manager at the Boston Crusaders, and before that was on staff at the Cadets Drum Corps from 2010 to 2016.

Mr. Lipman graduated with dual degrees in Music Education and Euphonium Performance from the Mason Gross School of the Arts at Rutgers University in New Brunswick, NJ. He is currently pursuing a Masters of Public Administration from the University of Texas at San Antonio.

Under Mr. Lipman's Direction, the Claudia Taylor Johnson Marching Band is a two-time Bands of America San Antonio Super Regional Champion and a three-time Grand National Finalist. In 2014, the marching band earned the Bronze Medal at the UIL 6A State Marching Contest and has been a consistent state finalist since 2012. The band earned the John Philip Sousa Foundation Sudler Shield for excellence in marching band performance in 2014. The Wind Ensemble is a consistent TMEA State Honor Band Finalist and performed at the Midwest Clinic in 2019. In 2014, Lipman was selected as the Phi Beta Mu International Bandmasters Fraternity Texas Chapter's Outstanding Young Bandmaster of the year.

#### Jodie Rhodes, Canyon Lake, TX

Jodie Rhodes has been in music education for the past 28 years teaching at both the middle school and high school levels. In addition, she has served as a clinician, consultant and program coordinator for several marching bands, drum corps, and concert bands around the country. Her groups have been frequent finalists at Bands of America Regional and Super Regional Championships, as well as at the Grand National Championships. In 2018, three of her groups made finals at the 6A UIL Texas State Marching Band Contest. Ms. Rhodes is also a frequent adjudicator of drum corps, marching, and percussion contests.

## Katie VanDoren, Cedar Park, TX

Katie VanDoren is a band director at Vandegrift High School in Austin, Texas. Originally from Cedar Park, Texas, Mrs. VanDoren graduated Summa Cum Laude from the University of North Texas with a bachelor's degree in Music Education.

Katie is currently the Assistant Brass Caption Head of the Santa Clara Vanguard Drum & Bugle Corps. Prior to this position, she spent 12 years with Carolina Crown and has been on the Brass Staff since 2013.

### John Phillips, Cape Coral, FL

John Phillips is Artistic Coordinator for the Southwest Florida Symphony Orchestra. He recently retired from Western University in London, Canada where he conducted the Symphonic Band, and taught conducting and music education classes at both the undergraduate and graduate level. He has previously been a faculty member at the University of Toronto and York University in the departments of music and education and coordinated the Arts curriculum review for the Ministry of Education in Ontario. As a clinician and consultant, John Phillips shares his unique brand of music education through presentations at State and Provincial Music Educators' Associations, the National Association for Music Education, and the Midwest Band and Orchestra Clinic. Throughout his career, he has participated in Music for All's National Festival, Summer Symposium, and Bands of America Grand Nationals. Each summer, he conducts the Wind Ensemble at the National Music Camp of Canada and was a guest conductor at the International Music Camp. Phillips has served as Judge Administrator for Drum Corps International and was inducted in the DCI Hall of Fame in 2015. John Phillips has contributed articles to the Canadian Music Educators` Association Journal, the Ontario Band Association newsletter, the Ontario College of Teachers journal, and to the highly acclaimed series Teaching Music Through Performance in Band. Phillips is a graduate of the University of Western Ontario where he received undergraduate degrees in both Music and Education. He pursued a master's degree in Music Education at Boston University, a PhD in Ethnomusicology at York University, and holds an Artist Diploma in trumpet performance from the Western Conservatory of Music.
