Levi Chavis, Garland, TX

Levi Chavis is currently the Fine Arts Coordinator/Director of Bands at Lake Highlands High School in Richardson, TX. From 2015 to 2017, he served as the first Director of Bands at Rick Reedy High School in Frisco, TX. In their inaugural year, the Reedy Wind Ensemble placed 6th in the 2016 TMEA 4A State Honor Band Contest. Prior to opening Reedy, Mr. Chavis was the Director of Bands at Ronald Reagan High School in San Antonio from 2009 to 2015. Under his direction, the Ronald Reagan High School Wind Ensemble was twice named a state finalist in the TMEA Honor Band Contest and was selected to perform at the Music for All National Concert Band Festival in Indianapolis, IN. The Ronald Reagan High School Marching Band was a consistent UIL State Marching Band Contest Finalist, Bands of America Regional and Super Regional Finalist, BOA Regional Class Champion and a Grand National Championship Finalist.

In 2015, Mr. Chavis was named the Outstanding Young Bandmaster by Phi Beta Mu's Texas chapter. He previously served on the instructional staffs of The Cavaliers and Santa Clara Vanguard Drum and Bugle Corps. He received his bachelor's degree from the University of Houston and is currently pursuing a master's degree in Music from Southern Methodist University. Mr. Chavis is an active adjudicator nationally and works as a program coordinator/consultant for multiple bands across the country. He currently resides in Garland with his wife Amanda and their daughter Sophia.

Chip Crotts, Acworth, GA

Dr. Chip Crotts serves as Director of Jazz Studies and Assistant Director of Bands at the Georgia Institute of Technology. He maintains an active career as a first call musician for national touring shows and orchestral dates throughout the United States.

As an educator and clinician, Dr. Crotts presents clinics nationally on Brass Pedagogy, Jazz Pedagogy, Breathing for Wind Players and Versatility in Performance. Currently, Dr. Crotts serves as Vice-President of the Georgia Association of Jazz Educators, as well as being a member of NAfME, the American Federation of Musicians, the Jazz Education Network and

The International Trumpet Guild. He is a past fellowship recipient from the Aspen Music Festival and Music at the Banff Centre (Canada), as well as a grant recipient from the National Endowment for the Arts, Georgia Tech Foundation, and recent selection as a Georgia Tech "Class of 1969 Teaching Fellow."

Dr. Crotts has served as a brass instructor with Spirit of Atlanta, Phantom Regiment, The Cavaliers, Santa Clara Vanguard and is presently Brass Caption Head for the 19-time World Champion, Blue Devils. Chip is active as a clinician and adjudicator and has served in this capacity with organizations such as Bands of America, Drum Corps International, Drum Corps Japan, DCI Taiwan Marching Academy, Winter Guard International, and numerous state and national music educator associations.

Dr. Crotts received his undergraduate degree in Music Business from East Carolina University, a Master of Music in Orchestral Performance from Penn State University, as well as the Doctor of Musical Arts degree in Trumpet Performance with a Jazz Emphasis from the University of Texas at Austin

Previously, Chip served on the faculties of Samford University, Jacksonville State University and The University of Texas at Austin. Dr. Crotts resides in Acworth, GA with his wife Kelly and daughter Abigail.

Glenn Fugett, Nashville, TN

Glenn Fugett is currently the Secondary Music Coach for the Metro Nashville Public Schools. From the summer of 2015 to May of 2019, he was the Director of Bands and Orchestras at the Nashville School of the Arts. In the spring of 2019, the NSA Wind Ensemble received the Award of Distinction in Concert Performance from the American School Band Directors Association. His chamber orchestra and wind ensemble were both selected to the Music for All National Festival in March of 2017.

From 2007 through June of 2015, Glenn was the Director of Bands at Legacy High School in Mansfield, Texas. The group was a finalist at numerous BOA Regional Championships, they were the 3A Class Champions at the 2011 Arlington and 2013 Allen Regional Championships. The Legacy Wind Ensemble performed at the MFA National Concert Festival in 2014. He was the Associate Director of Bands at Westlake High School in Austin, Texas from the fall of 1991 through the spring of 2007. The Westlake Band performed at the Midwest Clinic in 2002, the Tournament of Roses Parade in 2003 and was a consistent finalist at the San Antonio Bands of America Super Regional and the UIL State Marching Contest.

Glenn is a sought-after clinician for Music for All and Yamaha. Glenn has been a judge for Bands of America since 1995 and a judge for Drum Corps International since 1992.

Jason Robb is currently the Director of Bands at Rouse High School in Leander, Texas. He received his Bachelor of Music in Education and Trumpet Performance from Sam Houston State University.

Since assuming his position at Rouse, the program has been a Bands of America Regional Finalist, Regional and Super Regional Class Champion, and 5A UIL State Marching Championship Finalist. Robb was named the Phi Beta Mu Texas Young Bandmaster of the Year in 2018.

Robb spent 8 summers teaching on the Brass Staff of the Madison Scouts from Madison, Wisconsin. He served as a high brass specialist and returned to Madison serving as the program coordinator for the 2020 season. He spends his non drum corps summertime designing and coordinating marching band productions, writing marching band drill, and consulting with high school band programs around the country through his company J•Robb Designs. Under his direction, the Union Band saw exponential growth in student participation, while also receiving top rankings and ratings at numerous local, state, regional, and national events.
